



## INTRODUCTION

Please read these terms and conditions carefully as it constitutes a legally binding agreement between you and REM International payments Inc. (“Rempic”, “we”, “our” or “us”) in respect of access and use of Rempic’s website located at [Rempic.com](https://Rempic.com), and any subdomains used in connection with or related to the same and any future versions (“website”) as well as Rempic mobile applications (“Rempic app”). together the future version of the Rempic app, and the website constitute the (“[Rempic.com](https://Rempic.com)”).

These terms and conditions apply to all users of the Rempic platform, including merchants and service providers, persons who download the Rempic app and users who simply view the content on or available through the website (“content”).

In order to use the Rempic platform, you have reached age of majority in your jurisdiction of residence. Rempic does not permit the use of the Rempic platform on behalf of another person or entity. the term “user”, “you” or “your” refers to the individual, as applicable, accessing or otherwise using Rempic platform or the Rempic services.

The Rempic platform is used to deliver services which may be subject to additional terms and conditions.

By accessing, browsing and using the Rempic platform, you acknowledge that you have read and accept these terms and conditions. if you do not accept these terms and conditions, then you may not access or use the Rempic platform.

### 1. User & Applicable Terms

**Users.** The Rempic platform facilitates access by customers and other users of the Rempic platform (“Customers”) to various services, including financial services offered in association with other financial institutions (collectively “Rempic Services”). Collectively, they constitute “Users” of the Rempic Platform and these Terms and Conditions apply to all Users.

**Privacy Policy.** Rempic’s Privacy Policy (“**Privacy Policy**”) applies to the Rempic platform and Rempic services and is available at [Rempic.com](https://Rempic.com) or upon request. The Privacy Policy may be amended from time to time. By agreeing to these Terms and Conditions, you are also agreeing to the terms of the Privacy Policy, and you undertake to review those terms, as such may be amended from time to time.

**Additional Terms.** These Terms and Conditions are for access and use of the Rempic Platform and are in addition to separate agreements with Rempic with respect to Rempic services. In the event of any conflict between these Terms and Conditions and these additional agreements, the terms of such additional agreements will prevail.

**Service Providers.** These Terms and Conditions are entered into between you and Rempic. We may contract with third-party service providers, including merchants, financial service



providers and other parties (“Service Providers”) with respect to one or more of the Rempic Services or parts thereof. Rempic, and not its Service Providers, is solely responsible for the Rempic Platform, including any maintenance and support, and its content. However, you agree that the Service Providers, along with their respective affiliates, are third-party beneficiaries of these Terms and Conditions. Upon your acceptance of these Terms and Conditions, the Service Providers will have the right to enforce these Terms and Conditions against you as third-party beneficiaries regarding their respective services.

**Modification of these Terms or Rempic Platform.** Subject to applicable law, we reserve the right to restrict, suspend or otherwise change any aspect of the Rempic platform, and we may modify all or one or more parts of these Terms and Conditions at any time. In the event these Terms and Conditions, or any material aspect of the Rempic platform, is changed, we will provide you advance notice by posting a notice and the amended Terms and Conditions on the Rempic platform, and if you have a Rempic account (as defined below), by sending you notice using your registered email or mailing address. Your continued use of the Rempic platform following such notice will constitute your consent to any amendments to these Terms and Conditions, or any other aspects of the platform. If you do not agree to any such amendments, you may stop using the Rempic platform without cost or penalty.

## **2. Rempic Accounts**

**Accurate Information.** You represent and warrant that all information supplied by you through or for the Rempic platform (including information provided by you to create an account for use of the Rempic platform (a “Rempic Account”) or in connection with your use of the Rempic services is true, accurate, current and complete.

**Security of Rempic Accounts.** Any Rempic account must be kept secure and you agree that you will not share or disclose your credentials with anyone. Rempic will not be liable for any loss or damage arising from your failure to safeguard your account or use by any third person of your credentials. You must use a strong password and limit its use to your Rempic account.

**Suspension or Termination of Access to the Rempic Platform.** We may suspend or terminate your ability to access the platform, at any time if we believe you may have violated these Terms and Conditions or other agreements for use of the platform or services, or that you may create risk or possible legal exposure for us. We may also suspend your ability to access the platform if: (i) you have not accessed your Rempic account for more than twelve months; or (ii) to maintain or protect the integrity or operation of the platform. Suspension or termination may also include removal of some or all of the materials uploaded by you. You acknowledge and agree that all suspensions or terminations may be made by Rempic in its sole discretion and that Rempic will not be liable to you or any third party for any suspension or termination of your access or removal of any of the materials uploaded by you to the Rempic platform. Rempic will suspend your access only for as long as Rempic deems it necessary to resolve or prevent



the issues leading to the suspension. Any suspension or termination by Rempic will be in addition to any and all other rights and remedies that Rempic may have.

**Account Deletion and Termination.** Subject to the terms of your Rempic account agreement(s), you may request the closing of your account by requesting (by email or through any then-available interfaces) that your account be closed, ceasing use of the Rempic platform and the services.

**Retention of Account Information.** In accordance with our Privacy Policy, we may retain Rempic account information and your User Content and Submissions (as both terms are defined below) for document retention, fraud prevention, and legal and compliance reasons, including following termination of your Rempic account.

### 3. Licensed Access to the Rempic Platform and Permitted Use

**License to Rempic Platform.** Subject to your compliance with these Terms and Conditions, Rempic hereby grants you a personal, revocable, non-exclusive, and non-transferable license to use the Rempic platform in accordance with these Terms and Conditions. Customers may use the Rempic platform only in connection with Rempic services (the “Permitted Use”).

**Reservation of Rights.** Rempic retains the right, at its sole discretion, to revoke its license and deny access to the Rempic platform to anyone, at any time and for any reason (or no reason at all), including, but not limited to, for violation of these Terms and Conditions or use other than the Permitted Use. You will cease and desist from any such access or use of the Rempic platform immediately upon request by Rempic.

**Geographic Application of the Rempic Platform.** The Rempic platform or specific Rempic services may not be available at all or any times and in all or any jurisdictions. Furthermore, nothing on the Rempic platform constitutes an offer or solicitation to buy or sell any services or other products or services to anyone in any jurisdiction in which such an offer or solicitation may be prohibited by law.

**Changes to the Rempic Platform.** Rempic reserves the right to change or allow a third party to change any information, material, or content (including, but not limited to, price, features, availability of products, and services) contained on or provided through the Rempic platform at any time, and from time to time, without notice or liability.

### 4. No Unlawful or Prohibited Use

**Restricted Activities and Persons.** To access the Rempic platform, you represent and warrant that:

- I. You are not located in a country that is subject to a Canadian or U.S. Government embargo, or that has been designated by the Canadian or U.S. Government as a “terrorist supporting” country.
- II. you are not listed on any Canadian or U.S. Government list of prohibited or restricted parties.



- III. You will not use the Rempic platform in or for the benefit of a country, organization, entity, or person embargoed or blocked by any government, including any person/entity on government sanctions lists.

**Other Improper Uses.** You may not use the Rempic platform or any Content for purposes other than the applicable Permitted Use. Without limiting the generality of the foregoing, you will not, and will not permit anyone else to, or attempt to use the Rempic platform or the Content to:

- I. “frame”, “mirror” or otherwise incorporate the Rempic platform or the Content or any part thereof on any commercial or non-commercial website.
- II. access, monitor or copy any part of the Rempic platform or the Content using any robot, spider, scraper or other automated means or any manual process for any purpose without Rempic’s express written permission.
- III. violate any laws.
- IV. violate the restrictions in any robot exclusion headers on the Content or the Rempic platform or bypass or circumvent other measures employed to prevent or limit access to the platform
- V. remove (or permit anyone else to remove) any watermarks, labels or other legal or proprietary notices included in the Rempic platform or the Content.
- VI. modify or attempt to modify (or permit anyone else to modify or attempt to modify) the Rempic platform for the purpose of disguising or changing any indications of the ownership or source of the Rempic platform.
- VII. forge headers or otherwise manipulate identifiers in order to disguise the origin of any material transmitted to or through the Rempic platform or impersonate another person or organization or misrepresent their affiliation with a person or entity.
- VIII. attempt to, assist, authorize or encourage others to circumvent, disable or defeat any of the security features or components, such as digital rights management software or encryption, that protect the Rempic platform or the Rempic services.
- IX. copy, reproduce, modify, translate, distribute, transfer, sell, publish, broadcast, perform, transmit, license or circulate in any form any part of the Rempic platform or the Content.
- X. license, sell, rent, lease, transfer, assign, distribute, host, or otherwise commercially exploit the Rempic platform.
- XI. create derivative works based on the Rempic platform, services or the Content, in whole or in part, or decompile, disassemble, reverse engineer or otherwise exploit any part of the Rempic platform, its services or the content.
- XII. use or access the Rempic platform in a manner that violates the rights (including, but not limited to contractual, intellectual property or proprietary rights) of any third party.



- XIII. upload to or transmit through the Rempic platform any information, images, text, data, media or other content that is offensive, harmful, tortuous, hateful, obscene, defamatory or violates any laws or is otherwise objectionable, in each case as determined by Rempic in its sole discretion.

## **5. Marketing, Alerts and Access to Mobile Devices**

**Marketing Materials.** Rempic may provide you with marketing or promotional materials through the Rempic platform, mail, phone, email, text, or other methods. Rempic may have arrangements in place in connection with any such marketing or promotional materials where we may be entitled to receive a referral or other fees from third parties. Please refer to Rempic's Privacy Policy, available at [https://rempic.com/wp-content/uploads/2023/03/Privacy\\_policy.pdf](https://rempic.com/wp-content/uploads/2023/03/Privacy_policy.pdf) for more information on our use and protection of your personal information for marketing.

**Alerts.** Rempic may from time to time provide automatic alerts and voluntary Rempic account-related alerts. Automatic alerts may be sent to you following certain changes to your account or information, such as a change in your registration information. Voluntary account alerts may be turned on by default as part of the services. They may then be customized, deactivated, or reactivated by you. Rempic may add new alerts from time to time or cease to provide certain alerts at any time upon its sole discretion. You understand and agree that any alerts provided to you through the Rempic platform or services may be delayed or prevented by a variety of factors. Rempic may make commercially reasonable efforts to provide alerts in a timely manner with accurate information, but cannot guarantee the delivery, timeliness, or accuracy of the content of any alert. Rempic will not be liable for any delays, failure to deliver or receive, or misdirected delivery of any alert; for any errors in the content of an alert; or for any actions taken or not taken by you or any third party in reliance on an alert.

**Access to Mobile Devices.** We may provide features that rely on the use of additional information on your mobile device or require access to certain services on your mobile device that will enhance your use of the Rempic platform and services but are not required to use most services. If you grant access to such services, our access will only be for the purposes set out when you grant such access.

## **6. Intellectual Property**

### **Content and Intellectual Property**

- I. Rempic Content. The Rempic platform and all content contained therein (excluding User Content), is owned or licensed by Rempic and protected by copyright, trademark and other intellectual property laws. Rempic expressly reserves all rights, titles and interests in the Rempic platform, its content and all other materials provided by Rempic in connection with these Terms and Conditions that are not specifically granted to you. You acknowledge that all right,



titles and interests in the Rempic platform, content, and all other materials provided by Rempic in connection with these Terms and Conditions, and any modification or derivative work thereof, and all intellectual property rights therein, including without limitation moral rights, will remain with Rempic (or third party suppliers or licensors, if applicable), and that the Rempic platform, content and all materials provided by Neo hereunder are licensed and not “sold” to you.

- II. **User Content.** All information, data, text, software, music, sound, photographs, graphics, video, messages, or other materials, whether publicly posted or privately transmitted to the Rempic platform by Users (“User Content”), is the sole responsibility of such Users. This means that the User, and not Rempic or its shareholders, directors, officers, employees, agents, or representatives (collectively, “Rempic members”), are entirely responsible for all such material uploaded, posted, emailed, transmitted, or otherwise made available on the Rempic platform. Rempic may monitor User Content from time to time, but Rempic does not guarantee the accuracy, integrity, or quality of such content. For the avoidance of doubt, Rempic has no obligation to post or display any User Content on the platform.

**Use of Rempic Content and User Content by other Users.** You may only use Rempic content and user content of others for the applicable Permitted Use. If you print extracts from the Rempic platform for your own personal, non- commercial use, you must not modify the digital or papers of such materials or use any graphics, pictures, photographs or videos separately from any accompanying text.





## Terms on Submissions and Other User Content

- I. Creating Submissions and Other User Content. Through the capabilities of the Rempic platform you may be able to provide ratings/reviews, suggestions or other feedback ("**Submissions**"). Submissions are a subset of User Content. In addition to any and all representations and warranties set out in these Terms and Conditions, in creating and posting any Submissions (or other User Content), you represent and warrant that you will not post or transmit to or from the Rempic platform any material or content which does or may: (i) breach any applicable local, provincial, territorial, federal, national or international law; (ii) be unlawful or fraudulent; (iii) amount to unauthorized advertising; (iv) contain any defamatory, obscene or offensive material; (v) promote violence or discrimination; (vi) infringe the intellectual property rights of another person; (vii) breach any legal duty owed to a third party (such as a duty of confidence); (viii) promote illegal activity or invade another's privacy; (ix) give the impression that they originate from us; or (x) be used to impersonate another person or to misrepresent your affiliation with another person. You will be solely liable for any damages of any kind resulting from any violation of the foregoing restrictions, or any other harm resulting from your posting of Submissions or other User Content to the Rempic platform.
- II. Status of Submissions on the Rempic Platform. We reserve the right to remove or edit at any time any Submissions or other User Content posted, uploaded or transmitted to the Rempic platform that we determine breaches the restrictions in the User Content section above or is otherwise objectionable or may expose us or any third parties to any harm or liability of any type, or for any reason. You acknowledge and consent to Rempic using your given name and province or territory of residence in association with

## **11. Indemnification**

**Indemnity.** You agree to defend, indemnify and hold harmless the Rempic Parties from and against any threatened or actual claims, causes of action, demands, recoveries, losses, damages, fines, penalties, costs, expenses or other liability of any kind or nature including but not limited to reasonable legal fees, incurred in connection with or as a result of:

- I. Your breach of these Terms and Conditions or any documents referenced herein;
- II. Your violation of any law or the rights of a third party (including proprietary and/or intellectual property rights); or
- III. Your breach of, or failure to, perform in respect of any offers redeemed by you or by any third party acting on your behalf or with your permission.

**Assuming Defense.** Rempic reserves the right, at its own expense, to assume the exclusive defense and control of any matter otherwise subject to indemnification by you hereunder, and you will cooperate as fully as reasonably required by Rempic.

## **12. Governing Law and Dispute Resolution**

**Governing Law.** This Agreement shall be governed by and interpreted in accordance with the laws of the province or territory in which you reside and you agree to submit to the jurisdiction of the courts of the province or territory in which you reside. These laws apply to your access to, or use of, the Rempic platform its services offered through the platform, or the Content, notwithstanding your domicile, residency or physical location.

- II. Except to the extent restricted by applicable law, you and us agree that you and us will resolve any Dispute on an individual basis. Any claim you may have must be brought individually, in your individual capacity and not as a representative plaintiff or class member, and you will not join such claim with claims of any other person or entity, or bring, join or participate in a class action lawsuit, collective or representative proceeding of any kind (existing or future) against any members of Rempic.
- III. Nothing in this Section will prohibit us from seeking interim measures from a court, including preliminary or injunctive relief of breach of you of any intellectual property rights.

#### **Miscellaneous**

**Interpretation.** Unless the context clearly requires otherwise: (a) references to the plural include the singular, the singular the plural, the part the whole; (b) “including” means “including, without limitation”; and (c) references to “hereunder” or “herein” relate to these Terms and Conditions. The section headings in these Terms and Conditions are for reference and convenience only and will not be considered in the interpretation of these Terms and Conditions.

**Entire Agreement.** These Terms and Conditions and any documents incorporated by reference herein constitute the entire agreement between Rempic and you pertaining to the subject matter hereof and supersede all prior or contemporaneous communications and proposals, whether electronic, oral or written, between you and Rempic with respect to the Neo Platform, except as otherwise stated herein.

**Notices.** Rempic may, in its sole discretion, provide any notices to you in connection with these Terms and Conditions through the Rempic platform or by email at the then-current email address for you on file with Rempic. Rempic may change its notice contact information from time to time by posting updated contact details on the Rempic platform.

**Force Majeure.** Rempic will not be liable to you for any failure of or delay in the performance of its obligations under these Terms of and Conditions for the period that such failure or delay is due to causes beyond Rempic’s reasonable control, including but



not limited to acts of God, natural disasters, power outages, internet dysconnectivity, war, strikes or other labour disputes, embargoes, government orders or any other force majeure event.

**General.** Rempic failure to insist upon or enforce strict performance of any provision of these Terms and Conditions will not be construed as a waiver of any provisions or right of Rempic. If any of the provisions contained in these Terms and Conditions are determined to be void, invalid or otherwise unenforceable by a court of competent jurisdiction, the provision will be modified by the court and interpreted so as best to accomplish the objectives of the original provision to the fullest extent permitted by law, and the remaining provisions of these Terms and Conditions will remain in effect. These Terms and Conditions and all related documents have been drafted in the English language at the express request of the parties. You may not transfer any of your rights or obligations under these Terms and Conditions without our prior written consent. We may transfer any of our rights or obligations under these Terms and Conditions without your prior written consent to any of our affiliates or in connection with any joint ventures, sales or acquisitions.
